SWARUFFUR EDUCATIONAL & SOCIAL WELFARE TRUST, a Non-Government Educational & Social Welfare Trust with its office at Vill- Swaruppur, P.O. Hariharpara, Dist. Murshidabad, WB, Pin-742166, hereinafter referred to as SWARUPFUR EDUCATIONAL & SOCIAL WELFARE TRUST and represented by its Vice-Chairman, referred to as SECOND PARTY.

The First Party (HAZI A K KHAN COLLEGE), an Affiliated Institute under University of Kalyani, Governed by the UGC, is engaged in conferring General Degree to its Undergraduate students.

AND WHEREAS

The Second Party being desirous to conduct Programmes on,

1. Community related Work.

- 2. Helping and providing assistance in cash or kind to poor and / or destitute people and widows.
- 3. Helping and providing assistance to any scheme for providing livelihood and supplement to the poor.

4. Helping and providing food, medicine and other help in any shape or form to the poor, deserving and needy person.

5. Promoting and encouraging primary, secondary and higher education.

6. Providing grant to any person, institute or society or organisation in charitable purpose and to bear expenditure so incurred.

7. Rearing of cattle and useful animals.

ARTICLE 1: OBJECTIVE

General objective of this Memorandum of Understanding (MoU) is to motivate and facilitate collaborative activities between the two parties to:

1. Involve college students in several Awareness Programmes related to society.

2. Involve college teachers and staff to help in cash or kind to poor and/ or destitute people and widows.

3. Involve college to provide / help and assistance to any scheme for providing livelihood and supplement to the poor.

4. Encourage students of the college to participate in several activities in collaboration.

5. Inspire college students to participate in related seminars, workshops.

ARTICLE 2: RESPONSIBILITY

The First Party will extend cooperation to the Second Party in

- 1. Allowing students to take active part in programmes conducted by the Second Party.
- 2. Taking necessary measures to arrange related programmes in the college.

The Second Party will extend cooperation to the First Party in

- 1. Involving students and staff of the college in several community service works.
- 2. Motivating students in becoming good citizens of the nation

ARTICLE 3: VALIDITY OF THE AGREEMENT

This Agreement will be effected from the date of execution and shall be valid for five (05) years, unless sooner terminated, revoked or modified.

Either party may terminate the agreement at any time producing prior notice of one month to the other party.

ARTICLE 4: JURISDICTION

That in case of any dispute arises between the parties the same shall be referred to the Arbitration and shall be dealt with as per regulations of Arbitration and conciliation Act 1996. If the dispute is not settled out in Arbitration then only the same shall be referred to the competent court of Law and in such event the courts of Murshidabad Jurisdiction shall only have the exclusive right to entertain the same.
