ARTICLE 1: OBJECTIVE

- 4. Extend infrastructural help if needed to conduct any programme of the Second Party.

The Second Party will extend cooperation to the First Party in

- 1. Providing free/low cost eye related treatments to the students.
- 2. Motivating students in participating in several Awareness Programmes.
- 3. Providing chance to the students in participating in seminars/ workshops if any.

ARTICLE 3: VALIDITY OF THE AGREEMENT

This Agreement will be effected from the date of execution and shall be valid for three (03) years, unless sooner terminated, revoked or modified.

Either party may terminate the agreement at any time producing prior notice of one month to the other party.

ARTICLE 4: JURISDICTION

That in case of any dispute arises between the parties the same shall be referred to the Arbitration and shall be dealt with as per regulations of Arbitration and conciliation Act 1996. If the dispute is not settled out in Arbitration then only the same shall be referred to the competent court of Law and in such event the courts of Murshidabad Jurisdiction shall only have the exclusive right to entertain the same.
