By and Between

And

Mr. Mustafizur Rahaman, Proprietor of "SAALIAH EDUSPIRIT" vide Registration no . UDYAM-WB-13-0000236, Government of India , A Garment Manufacturing Unit and Educational Activities Farm, with its Registered Office at VILL + P.O- GOBARDHANDANGA, PS-SAGARDIGHI, DIST-MURSHIDABAD, PIN-742122 ,WEST BENGAL , INDIA, hereinafter referred to as the "Training , Placement and Industrial Partner" at the other part:

The Training, Placement and Industry Partner being desirous in providing a Skill Development Training Programme for,

6. Ware House Packing
7. Banking

Training, Placement and Industry Partner has approached the Training Partner to grant a "MOU" to participate in the Skill Development Programme (PMKVY-2023-2026/PBSSD/CSR) and the Training Partner has accepted to grant "MOU" to the Training & Placement and Industry Partner. The Training Partner has agreed to provide the required infrastructure.

Now therefore it is hereby agreed between the two parties to enter into an agreement hereto as under:

1. SCOPE:

1.1 The Training Partner shall provide the required infrastructure in rent basis.

1.2 The Training Partner and Training, Placement and Industrial Partner shall share their Login ID & Password to each other.

1.3 The Training Partner shall provide guidelines as laid down by NSDC/MSDE/SSC/PMKVY/PBSSD/DGT/NCVT/AICTE/CSR and coordinate for training the trainees, assessment, certification and subsidy /reward if any from NSDC/MSDE/SSC/PMKVY/PBSSD/DGT/NCVT/AICTE/CSR.

1.4 Training, Placement and Industrial Partner will impart the training as per the guidelines laid down by training Partner and NSDC/MSDE/SSC/PMKVY/PBSSD/DGT/NCVT/AICTE/CSR.

1.5 Training, Placement and Industrial Partner will provide assessment and placement support as per the guidelines laid down by training Partner and NSDC/MSDE/SSC/PMKVY/PBSSD/DGT/NCVT/AICTE/CSR.

2. RESPONSIBILITIES:

2.1 Training Partner (HAZI A K KHAN COLLEGE) shall responsible for:

a) Providing guidelines, NOS, QPs laid down by NSDC /MSDE /SSC /PMKVY /PBSSD /DGT /NCVT/AICTE/CSR and also align the courses.

b) Monitoring the training and its continual environment.

c) Coordinating with Sector Skill Council for assessment and Certification

d) Coordinating with NSDC/MSDE/SSC/PMKVY/PBSSD/DGT/NCVT/AICTE/CSR for Certification & Monetary Reward (If Any).

e) Conducting quality & financial audit time to time.

f) Provide guidance to Training, Placement and Industry Partner to provide proper training as per NOS/QPs of NSDC/MSDE/SSC/PMKVY/PBSSD/DGT/NCVT/AICTE/CSR.

3. TRAINING, PLACEMENT AND INDUSTRY PARTNER SHALL BE RESPONSIBLE FOR:

- a) Mobilization of the students as per eligibility criteria and interest of the candidate.
- b) The Training Partner & Training, Placement and Industry Partner shall pay the assessment fees to SSC equally (If needed).
- c) The evaluation of the candidate should be done by the Sector Skill Council and the Training, Placement and Industry Partner shall ensure that the evaluation is conducted properly.
- d) The Training, Placement and Industry Partner shall provide placement to minimum of the students trained.
- e) That the Training, Placement and Industry Partner have to submit the track record of every student from the date of Admission till the date of placement, in every month to the Training Partner.

4. VALIDITY OF THE AGREEMENT:

This Agreement will be effected from the date of execution and shall be valid till completion of scheme (PMKVY- 2023-2026/CSR).

5. SHARING OF THE REVENUE:

Training Partner (HAZI A K KHAN COLLEGE) will pay to Training, Placement and Industry Partner 90% out of total training cost for the purpose of Mobilization of candidates, Post Placement Expenses tracking/monitoring, Teaching-Aids, Salary of Trainers, Assessment Fees etc (Applicable for PMKVY).

If student enrolled under any scheme which is funded by Govt./NSDC like CSR/PMKVY/PBSSD/Utkarsha Bangla or any other, all the rules and regulation of the scheme need to be strictly followed and the revenue will be shared after the same is disbursed by the Govt./NSDC like CSR/PMKVY/PBSSD/Utkarsha Bangla.

6. JURISDICTION:

That in case of any dispute arises between the parties the same shall be referred to the Arbitration and shall be dealt with as per regulations of Arbitration and conciliation Act 1996. If the dispute is not settled out in Arbitration then only the same shall be referred to the competent court of Law and in such event the courts of Murshidabad Jurisdiction shall only have the exclusive right to entertain the same.
